# The Little Green Data Book

Dear Colleagues,

In the past month, the WAVES Partnership and work on Natural Capital Accounting has been featured in numerous high-level conferences on development, environment and oceans.

Rachel Kyte, Vice President for the World Bank's Sustainable Development Network, made a keynote speech at the seventh [Trondheim Conference on Biodiversity](#) in Norway at the end of May explicitly mentioning the work that WAVES is doing. Kyte told participants "*If we want a world without poverty where prosperity is shared, we need to help governments invest in their stock of natural capital to reap the long-term returns from its goods and services.*"

The 1st Global Legislators Organization (GLOBE) Natural Capital Summit took place in Berlin in early June, and was attended by legislators from 20 countries. In his [keynote speech](#), World Bank Director for Agriculture and Environmental Services, Juergen Voegele, stressed that valuing natural capital and sustainable development and poverty are intertwined and countries need to move "[Beyond GDP](#)" to achieve growth that is not tied to diminishing a country's natural resources.

The new edition of the World Bank's [Little Green Data Book](#) was released on World Environment Day 2013, and includes an adjusted net savings (ANS) indicator for more than 200 countries.



Summit attended by legislators from 20 countries, business leaders and UN, World Bank and GEF Reps; GLOBE Natural Capital Legislation Study also launched.




## [Natural Capital Accounting Highlighted at Trondheim Conference on Biodiversity](#)


