

# ADJUSTED NET NATIONAL INCOME (ANNI)

ANNI = GROSS NATIONAL INCOME √

- CONSUMPTION OF FIXED CAPITAL √
- DEPLETION OF NATURAL CAPITAL ~

# A. Definition and coverage

#### ADJUSTED NET SAVING (ANS)

ANS = GROSS NATIONAL SAVINING √

- CONSUMPTION OF FIXED CAPITAL √
- + INVESTMENT IN HUMAN CAPITAL
- DEPLETION OF NATURAL CAPITAL ~
- POLUUTION DAMAGES ~

	Corporation	SEC, Central Bank (Administrative data)
	Government	Administrative Data
Natural Capital	Land Resources	PEENRA Accounts (NAMRIA, HLURB, LMB, FMB etc.)
	Mineral & Energy Resources	Phil-WAVES (MGB, SEC, Central Bank)
	Timber Resources	PEENRA Accounts (FMB, NAMRIA etc.)
	Fisheries	BFAR, PSA etc.
	Water Resources	PAGASA, other water agencies
Human and Social Capital	Human Capital (Education Expenditures)	Satellite Accounts on Education (PSA)
