Key to the success of the project: ensure political commitment at the highest level.




II. Why these Accounts?

- NCA for better informed policy decisions:
 - National Plan for Integrated Management of Water Resources (PNGIRH): water as an economic good with value in all its diverse competing uses.
 - Water Account to monitor water use across productive sectors. Input for tariff estimation: decoupling economic growth from water use.
 - National Plan for Forest Development (forest land management, competitiveness of forestry industry, conservation, Payment for Environmental Services, mitigation and adaptation to climate change).
 - Need of a solid and innovative policy framework that recognizes the value and importance of forests to society: Forest Account to contribute visibility of relationships and connections of forests with national development agenda.




III. Uses of the Accounts: Opportunity Cost of Land and Water (C/ha/year)

III. Uses of the Accounts

Forests:

What is the contribution of forests to national wealth?

Payment for Environmental Services (PES).

Carbon neutrality strategy

Water:

Integrated management of water resources.

Long term supply (quantity and quality).

Water productivity (decoupling economic growth from unsustainable use of water)

Water as a human right



IV. Progress on the Accounts:

- Physical flow accounts for water have been compiled: main users and providers of water for the national economy.
- Preliminary asset account for water: based on national water balances.
- Work in progress: monetary flow account for water.
- Two case studies: preliminary account including physical and monetary supply and use tables for urban sector (ESPH); use of water in agriculture in rural areas (DRAT).
- First results from forest accounts that incorporate physical and monetary values.
- Preliminary timber and forest account has been compiled.
- Results of the new national forest inventory and a carbon dynamics study for REDD+ strategy to be integrated.



V. Uses and Reactions

- Several potential users and people interested in the forthcoming results.
- In-house workshops and technical meetings with key stakeholders (government, academia and other organizations) to raise awareness on the importance of NCA for policy decision making.
- Expectation from policy makers on accounts results: Ministry of the Environment working on a *policy incidence* strategy.

VI. Problems and Lessons learned

- Data is rarely available the "way it is needed:" learning process that involves not only economic and national accounts knowledge but diverse areas of study.
- Sources of information are scattered in various institutions with limited statistical knowledge.
- Start with "what you have" in terms of information, resources, stakeholder support, and technical knowledge: compilation of accounts is a continuous improvement process.
- Planning and project management is a must. However, room for *learning by doing* is necessary.



VII. The way forward

- Compile final versions of the accounts.
- Energy and Environmental Expenditure Accounts prospection.
- Policy incidence work to better inform and engage potential users of the accounts.
- Institutionalization: Roadmap for Accounts and National NCA Strategy (2016-2019)
- Staffing and programing at Central Bank of Costa Rica (BCCR)
