

National Context

- Colombia is located in South America
- Around 48 million of inhabitants
- Caribbean and Pacific coastlines
- One of the most megadiverse countries of the world
- With an internal armed conflict for the last 50 years
- Huge negative impacts for the NC country (USD 0.9 millions per year)
- Peace process- Habana agreements (2016)
- Sustainable uses of NC as alternative to "Green Growth Policy"



Vision

The construction and use of accounts can support the following future processes:

- Risk Management: Estimated national-level costs associated with forest losses, exacerbated by the El Niño phenomenon
- The dividends that Colombia would receive for each year of peace
- Green growth monitoring indicators
- Consolidated indicators for the National Administrative Department of Statistics'(DANE) System of Environmental and Economic Accounting
- Develop and update forest and water use rates
- Indicators for access to the Organization for Economic Cooperation and Development (OECD) and ODS
- Local level support indicators for environmental policy and management instruments, including for potential future payments for environmental services (PES) schemes.



Perspectives

- This work plan also recognizes the need to strengthen natural capital accounts in order to improve the availability of information, apply it to different sectors and institutions, strengthen Colombia's environmental information system (SIAC), and develop studies of ecosystems in order to collect timely information on the services and goods they provide.
- In terms of applying the accounts, a working agenda has been initiated by the head of the DNP, which is currently integrating different academic and institutional actors and, with the participation of the Inter-American Development Bank, is exploring the potential uses of the Integrated Environmental Economic Model (IEEM) in Colombia.
